Animal Registration Application

Animal Management (Cats and Dogs) Act 2008

Registration and renewal

Registration expires one year from the date of payment of the prescribed fee. A renewal will be issued prior to the expiry date. Failure to register or renew the registration is an offence under the Act. Fines apply.

Ownership transfers

For animals currently registered with Brisbane City Council phone (07) 3403 8888. No application required.

Reciprocal registration

To transfer the balance of registration to Brisbane City Council from another Local Government area, documentary proof from the previous Council indicating the registration is current must accompany this application. No registration fee is payable until the renewal application is issued.

Six months free registration

Animals purchased from the RSPCA, Council Animal Shelters, or pet shops and breeders licensed by Brisbane City Council are eligible to receive the first six months registration free. The application must be stamped and forwarded to Council by the seller. A renewal will be issued prior to the six month expiry date.

Registration fees, rebates and concessions

For current registration fees and eligibility criteria for rebates and concessions go to www.brisbane.qld.gov.au or phone (07) 3403 8888. GST does not apply to animal registration fees.

If you intend to desex the animal within the first year of registration the initial registration will be at the desexed rate. To continue to receive this rate, you must provide the vet's name and the date of desexing to Council within the first year of registration or the full registration fee will be charged for the following year.

Microchipping of cats and dogs

All cats and dogs must be implanted with a microchip before they reach 12 weeks of age. All cats and dogs sold or given away must also be implanted with a microchip.

Do I require an animal permit?

If you own more than three cats or two dogs or wish to register a guard dog go to www.brisbane.qld.gov.au, select Laws and Permits then Animal laws and permits for further information.

Regulated dogs

Owners of declared Regulated Dogs must indicate the declaration date, type (Dangerous, Menacing or Restricted) and the Local Authority that issued the Declaration. Restricted dog breeds are prohibited in Brisbane.

Assistance dogs

Guide, Hearing and Assistance dogs are exempt from registration fees if they comply with the *Guide, Hearing and Assistance Dogs Act 2009*.

Owner must have a Handler's ID Card. For further information go to www.qld.gov.au and search for assistance dogs.

Government entity/working dogs

Dogs that are on active duty for a government entity (agency) and working dogs that are kept on rural land and used for work purposes as stated under the Act are exempt from registration.

Cat breeds

If the cat is a pure breed write the breed in the Primary breed field. If the cat is not a pure breed write *Domestic short haired*, *Domestic medium haired* or *Domestic long haired* in the Primary breed field.
